- 5. The paper is submitted in doc (docx) format.
- 6. The size of the paper should be 4-6 pages.
- 7. Using of colored figures is allowed. In this case, the pdf-format of the article can't exceed 1 MB.
- 8. References should be made in accordance with IEEE-style:

- 9. There should be the references for at least 10 sources, and, with some exceptions, not older than 10 years.
- 10. Self-citation in the list of references is not desirable and is allowed, if necessary, in the amount not more than 10%.
- 11. Each author can be in the author's team of no more than two articles.
- 12. The author's team may include no more than four authors.

13. The presentation of the article and the report of at least one of the authors at the conference is compulsory.

Paper submission:

1. To submit materials, authors need to log into the EasyChair system at

- 2. If the author has never worked with EasyChair and is not registered in it, you must click on the "create an account" link of the login form. After creating an account, you need to log in to EasyChair.
- 3. After entering the conference area SMTESM-2019 on the page **New Submission** you need to download data about the article.
- 4. It is necessary to strictly adhere to terms of submission of articles.
- 5. All articles will be double-checked for plagiarism: the first by the organizers of the conference, the second by the publishing house. In case of plagiarism, the article will be rejected for publication.
